THERAPISTS (2 positions): To provide full array of mental health and substance abuse treatment including assessment, crisis intervention, individual and group therapy, and case management services to adults and children in outpatient mental health center located in Farmville. Incumbent must be licensed or licensed eligible in Virginia as Clinical Psychologist, LCSW, or LPC. Previous experience in similar setting providing therapy services required.
